It has been agreed with DCYA to make an additional payment on 20/12/19 to pay services which will be open in the week beginning 30/12/19.

Higher Capitation: an additional preliminary payment will be made on 20/12/19 to services that have made applications prior to 06/12/19 and have not been approved or declined. The payment will cover entitlement from beginning of the programme year to 27/12/19 (adjusted for any existing pre-payments).

Please note that each staff member can avail of a maximum of 18 hours of paid CPD training per calendar year and payments are calculated on this basis. Payments for all participants will be made to the employer/ childcare setting and NOT to the individual. Re-imburement by way of payment or time worked is the responsibility of the employer.
